Information we collect

When you access our website, www.ccu.org, we may collect the following information:

- Name
- Email Address
- Phone Number
- Device type used
- Browser & OS used
- IP Address
- The activity conducted on the page
- Location data
- Time and date of visit
- Time spent on page
- Traffic Source
- Clickstream data

What we do with the information we gather

We use the information for the following purposes:

- To operate and improve our products and services
- To respond to inquiries and provide customer service
- For internal reporting and record keeping
- For marketing purposes

We may share information with third parties who provide products or services on our behalf.

Google Analytics

This website uses Google Analytics, a web analytics service provided by Google, Inc. ("Google"). Google Analytics does not collect any personal information about a user but uses "cookies", which are text files placed on your computer, to help the website analyze how users use the site. The information generated by the cookie about your use of the website (including your IP address) will be transmitted to and stored by Google. Google will use this information for the purpose of evaluating your use of the website, compiling reports on website activity for website operators and providing other services relating to website activity and internet usage. Google may only transfer this information to third parties where required to do so by law, or where such third parties process the information on Google's behalf. Google will not associate your IP address with any other data held by Google. You may refuse the use of cookies by selecting the appropriate settings on your browser, however please note that if you do this you may not be able to use the full functionality of this website. By using this
